**Refund Rules:** The Schedule of refund of fees will be as follows as per UGC rule October 2018: If a student chooses to withdraw from the program of study in which he / she is enrolled, institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

<b>S. No.</b>	<b>Percentage of Refund of Aggregate fees</b>	<b>Point of time when notice of withdrawal of admission is served to HEI</b>
1	100%	15 days or more before the formally-Notified Last Date of Admission <b>(on or before Monday, 2<sup>nd</sup> November 2020)</b>
2	90%	Less than 15 days before the formally-Notified Last Date of Admission <b>(i.e., from 3<sup>rd</sup> November 2020 to 18<sup>th</sup> November 2020)</b>
3	80%	15 days or less after the formally-Notified Last Date of Admission <b>(i.e., from 19<sup>th</sup> November 2020 to 3<sup>rd</sup> December 2020)</b>
4	50%	30 days or less, but more than 15 days, After Formally-Notified Last Date of Admission <b>(i.e., 4<sup>th</sup> December 2020 to 18<sup>th</sup> December 2020)</b>
5	00%	More than 30 days after Formally-Notified Last Date of Admission <b>(i.e., after 19<sup>th</sup> December 2020)</b>

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.
